## What information do we collect about you

Each time you visit this website we collect information about you. We collect information about the time, date, duration and usage of our website and information regarding websites that referred you to our website.

We use non-personalised statistics about the use of our website to improve it and our service to customers.

If you submit information to UNiTAB using an electronic form or application, or if you submit wagers to us via this website or if you send us an email we will collect that information and use it for the purposes you have provided. We also collect information in order to comply with legislative and regulatory requirements.

In addition we may use your information to provide you with special offers, information about new products and special promotions which we think may interest you.

## Who we share your personal information with

Other than as between companies comprising the UNiTAB group and as may be required by law, we may also pass your personal information to organisations that are contracted to perform certain services for UNiTAB. This includes Australia Post and mailing houses (which includes mailing houses which distribute emails).

We do not disclose your personal information to organisations outside the UNiTAB group for their marketing purposes, although we may send you marketing information on their behalf.

Where appropriate, our website provides a secure environment by using a secure sockets layer. This establishes a session and encrypts all traffic between our web server and your browser.
